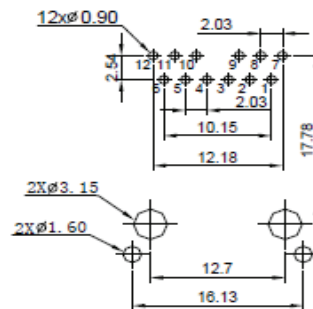
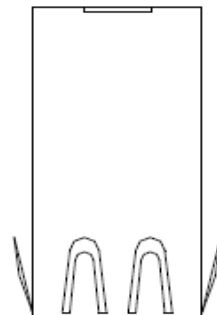


PC Board Layout  
Component Side Shown

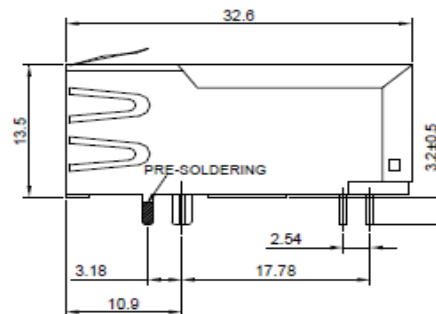
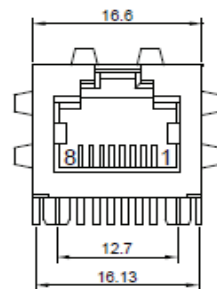
